Span of Time, Mode of evaluation & allocation of Marks, for various activities.

Field Work

A student is required to spend a minimum of six to eight hours per week for field work including following activities, during various spans of time.

Practicum – I (Agency visits-10 Agencies)

All the activities under, practicum – I shall be carried out during the first semester.

Practicum – II (Group Work)

Group Work activities shall be organized during second semester.

Practicum – III (Community Organization)

Activities under practicum – III shall be conducted & completed, during the third semester. It shall be carried out, during the third semester, under concurrent supervision of trained faculty, and for duration of four weeks. Twenty four days in a week and 280 hours in each semester have to be spent by the students in field work.

Recording, Reporting and Evaluation of the Practical

The students are required to write a weekly fieldwork report, in duplicate and retain one copy with them as a record each student will submit a summary report of fieldwork. duly examined by supervisor, at the end of respective semester (two weeks before the commencement of semester exam). The supervisor will also submit a detailed evaluation report of each student. However, in case of summer placement, students are required to submit a report, within two weeks of the commencement of third semester's classes

Block Placement-

Each student should be placed in an agency for – sixth days during fourth semester for internship.

Dissertation –

Each Student shall be required to do a dissertation, on a theme to be decided in consultation with competent faculty & will have to submit a report, two weeks before the commencement of fourth semester's exam.

Evaluation of the dissertation & viva-voce –

Evaluation of all be reports (Field work reports & dissertation comprehensive viva-voce exam shall be done by a board of examiners, Including.)

- (i) Internal examiner.
- (ii) External examiner.

(head of department shall be the convener of board)

*Evaluation of reports for Practical – I & II, Shall be done, During Third Semester,

*Reports of Practical III & dissertation shall be evaluated, at the end of fourth semester.

Marks shall be awarded by all be examiners jointly & in a manner prescribed below:

- Maximum Marks allocated to practical I, II & III respectively, shall be one hundred (50) for each ingredient of practical.
- Max Marks allocated to dissertation & Viva-Voce respectively, shall be fifty (50), for each event,

Allocation of marks for theory papers.

(This type of Marks allocation shall be applicable to semester system only)

- Max Marks for each theory paper shall be sixty.
- Out of seventy five, there shall be an internal assessment of fifteen & sixty marks for external evaluation (15:60)
